# Loneliness, Isolation, and Diversity: Pursuing Justice through Occupational Therapy and Occupational Science

In the fields of occupational therapy and occupational science, there has been a long-standing discussion about how the structures of society and communities impact our health and occupations. However, the exploration of how we can specifically contribute to addressing issues of loneliness and isolation in society is just beginning. This symposium focuses on the impacts of these issues in today's society, where diverse identities and social challenges intersect, and proposes new inclusive approaches.

We, Takashima, who works on the issues of loneliness and isolation among older people, and Hoshino, who addresses these issues among individuals with mental illness, have established a platform based on scientific evidence to explore how occupational therapy and occupational science can promote social justice and inclusion.

This symposium brings together 16 experts from five countries. Going beyond the academic realm, we collaborate with practitioners, governmental and other agencies, and the general public to contemplate concrete methods for building a more just and healthy society. We sincerely hope that your participation will bring fresh perspectives to this vital discussion and help deepen understanding.
